

- ✓ All full time faculty members as per AICTE Norms must be recruited before making admissions
 - ✓ The Institution must have Affiliation to a University for the above year as before making admissions. In the absence of such Affiliation, this Letter of approval shall be treated as Withdrawn. (Order of the High Court of Madras in W.P. No. 256 of 2002 and other Batch of Petitions)
 - ✓ All the required Laboratories, Workshops, Machinery, Equipment as per approved syllabi of the affiliating University, must be operational before making admissions.
 - ✓ The approved courses shall commence as per the academic calendar of the affiliating University
 - ✓ If this Letter of approval is received by you after the closing date of State/National Level Central Counseling for Admissions in the concerned State/Union Territory, this Letter of approval will not be valid for making any admission during the above specified academic year, and shall be treated as withdrawn.
 - ✓ No excess admission shall be made by the Institution, over and above the AICTE approved intake during any academic year.
 - ✓ Name of the Institution, Name of the Society, Trust, are not allowed to be changed without prior approval of AICTE. The name and title of the institution should be such that "the Emblems and Names (Prevention of improper use) Act 12 (1950)" of Government of India, is not violated in any manner.
 - ✓ The use of word "Indian" and/or "National" and/or "All India" and/or "All India Council" and/or "Commission" in any part of the name of a Technical Institution and/or any name whose abbreviated form leads to "IIM", "IIT", "IISc", "IIT", "AICTE"/ "UGC" shall not be permitted. These restrictions will not be applicable for those institutions which are established with the name approved by the Govt. of India.
 - ✓ In exercise of power conferred under 10(p) of the AICTE Act, AICTE, may inspect the Institution any time it may deem fit to verify the progress/compliance or for any other purpose.
 - ✓ Any other condition(s) as may be specified by AICTE from time to time.



Suggestive Improvements:

INFRASTRUCTURE:

- The total built-up area for Management programme must be improved to match with AICTE norms (Built-up area required - 1,248 sqm).
- The institute must try to convert the Management programme to a residential programme by constructing own hostels.
- The area available for classroom, computer centre, library must be improved to match with AICTE norms.
- Student's amenities must be improved by providing students common room, canteen and recreational facilities.

COMPUTER CENTRE & LIBRARY:

- Computer Laboratory must be set up exclusively for Management programme with PC's with latest configuration so as to fulfill AICTE norms (Requirement - 30).
- The Computer Laboratory must be connected with switched ethernet LAN with structured cabling. Internet facility of atleast 64 KBPS through leased line / VSAT be provided. Licensed software with managerial application as per syllabus etc. be procured.
- More contemporary titles of relevance be procured to make the total number of titles so as to match with AICTE norms.
- Efforts be made to modernized the library by networking with other libraries and Digital Library be set up. Photocopier machine should be made available in the library.
- More number of journals be subscribed regularly as per AICTE norms (30).

FACULTY:

- Principal / HOD be appointed as per qualification and experience as per AICTE norms.
- Senior faculty at the rank of Professor / Assistant Professor be increased as per AICTE norms and total number of regular faculty be increased as per AICTE norms.
- Two / three Visiting / Part time faculty may be recruited in each key areas.
- AICTE Pay Scales with DA be implemented for the entire faculty.

OTHERS:

- The Placement Cell may be establishment / strengthened with adequate infrastructure and facility including Telephone, Fax, E-Mail etc. with a full time Placement Officer.
- Faculties may be encouraged to attend training programme, seminar, workshop, conferences etc. for their professional growth.
